# The type of personal information we collect

#### How we store your personal information

Your information is securely stored.

We keep personal information in the form of names, contact details, addresses and financial information for an indefinite amount of time, or until your consent is withdrawn. We will then dispose your information by securely deleting it from our central contact databases, email accounts and accounting software (both kept with secure passwords and two-step verification).

### Your data protection rights

Under data protection law, you have rights including:

**Your right to data portability** - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
